Northern Gas Networks' Metering Charges from 1st September 2009

Please find attached schedules showing Northern Gas Networks' revised metering charges to apply from 1st September 2009. This notification is provided 3 months in advance of the effective date consistent with the notice period required in Northern Gas Networks' Metering contracts.

Northern Gas Networks' metering charges are regulated by a price control set by Ofgem, the gas industry regulator. Ofgem has set tariff caps for four key metering services and charges for these services must not exceed the tariff caps, which are increased each year by inflation (RPI).

Northern Gas Networks has not implemented charge increases since 1st May 2007. The revised rental charges effective from 1st August 2009 incorporate an increase in respect of inflation for this two year period of 8.75%. The domestic annual charges are set to the regulated tariff caps and are £14.73 for a credit meter, £34.38 for a prepayment meter. The transactional charge for a customer requested domestic meter exchange is capped at £60.28. The charge for a daily meter reading service is capped at £445.49.

Northern Gas Networks is also adjusting its transaction charges for meter works to reflect increases in underlying costs since 2007. Overall transaction charges will increase by 11%.

Transactional Charges

Any work downstream of the outlet of the meter is excluded unless specifically mentioned. In all cases, service pipe installation, alteration and disconnection and meter box provision is excluded and will be subject to additional charges.

The following charges relate to domestic-size meter installations, where the meter capacity is less than 11 standard cubic metres per hour (scmh).

4. All work shall be carried out in accordance with “General Conditions of Contract for Adversarial Meterworks”. These charge rates also apply in respect of purging meters and downstream installations.

The following charges relate to installation and removal of larger diaphragm meters. These charges apply only in respect of standard low pressure installations, where no enhancements (e.g. bypasses) are required.
