## **Supply Chain Mapping Statement 2022/23**

## Characterising our Supply Chain




Figure 1 – Cumulative supply chain expenditure by NGN in period 1 April 2022 to 31 March 2023

As shown on Figure 1, during the period 1 April 2022 to 31 March 2023 Northern Gas Networks (NGN) spent £216m on goods and services from nearly 800 direct suppliers, 80% of which by value was with approximately 60 suppliers. Our principal area of expenditure was gas mains replacement and reinstatement contractors ('utility works contracting services') which accounted for 40% of our expenditure on goods and services. A full list of the suppliers making up the top 80% of our 2022/23 direct expenditure is provided in Appendix A.

Small and medium sized enterprises (SMEs) form an important part of our supply chain. We are starting to collect data to enable quantification of our expenditure with SMEs. During 2022/23 we had this data for 23% of our total suppliers and consequently know that 61% of our total expenditure (£131m) was with SMEs. Of the suppliers in Appendix A which comprised 80% of our total expenditure in 2022/23, over half of them were known to the SMEs.

NGN publish a Modern Slavery Transparency statement on our <u>website</u> which demonstrates our commitments and procedural controls. As demonstrated by Appendix A, our primary direct (Tier 1) suppliers are UK based.

## Supplier Selection and Vetting

For core business procurement events we preferentially engage suppliers who have been approved via the Achilles Utilities Vendor Database, an independent supply chain assurance assessment. In addition, potential suppliers for procurement events are typically required to complete a prequalification questionnaire (PQQ) which as standard includes questions regarding their environmental management systems, past environmental performance, corporate environmental objectives, how



they meet our EAP objectives and their sustainable business practices, and are awarded scores accordingly. It is of note that we aware that many of our suppliers have set their own sustainability metrics and targets but we do not have access to data regarding the proportion of suppliers that have these and as such cannot provide performance data on this.

## Supplier Code of Conduct

During 2021/22 we worked with our stakeholders to finalise our <u>Supplier Code of Conduct</u> ('supplier code') and associated compliance process. Our supplier code is aligned to the UN Sustainable Development Goals and requires our suppliers to operate to high standards of environmental management and sustainable business practices.

We have a business commitment to achieve at least 80% of our suppliers (by value) complying with our supplier code by the March 2026. During 2022/23 79% of our total spend was with suppliers who have signed up to our supplier code.
